Terms and conditions governing the engagement of Pharmacist on contractual basis

1. The appointment is purely on contract basis for a period of 180 days or till the regular incumbent joins, whichever is earlier, with effect from the date of joining. Thereafter, the contract will lapse automatically.
2. The consolidated remuneration will be Rs. 17,000/- per month or last pay drawn minus pension fixed whichever is less.
3. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra / additional allowance will be admissible in case of such assignment.
4. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
5. The appointee will not be granted any claim or right for regular appointment Central Government Health Services.
6. Only consolidated salary will be admissible. No Dearness Allowance and other allowances admissible to the Central Govt. servants shall be admissible.
7. The appointment shall be on the whole time appointment and shall not accept any other appointment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
8. The appointment carries with it the liability to serve in any CGHS wellness centre of CGHS Bhubaneswar.
9. The appointment to the said post will be subject to physical fitness from the competent medical board for which he/she will be sent to the designated medical Authority after his / her joining and in case he/she is found medically unfit, he / she will be discharged from the said appointment forthwith.
10. The appointee is required to submit a declaration regarding his/her marital status.
11. Contractual employee will be eligible for 8 days leave in a calendar year on pro-rata basis. Therefore, the Pharmacist shall not draw any remuneration in case of absence beyond 8 days in a calendar year.
12. On appointment, the appointee will be required to take an oath of allegiance to the Constitution of India or make a solemn affirmation to that effect in the prescribed proforma.
13. The appointee is not entitled to any TA for joining the appointment.
14. Other conditions of service will be governed by relevant rules and orders issued from time to time by Govt. of India for contractual employment.
15. If any declaration given or information furnished by him/her proves false or if he/she is found to have willfully suppressed any material, information, he/she will be liable to removal from service and also such other action as the Government may deem necessary.
16. If disciplinary proceeding in last 5 years of services is found against him/her appointment will be terminated with immediate effect.
17. If he/she accept the contract appointment on the above terms and conditions, he/ she should immediately convey the acceptance and report for duty within 3 days to the AD,CGHS, Bhubaneswar, failing which it will be presumed that he/she is not interested in the appointment offered and the same will be treated as cancelled.
